## Young Leader Awards Nomination Reminder

Each year, the College of Pharmacists of Manitoba, along with Pharmacists Manitoba, jointly present the Young Leader Awards to deserving recipients. These awards celebrate the efforts of future leaders in pharmacy practice, while offering them an opportunity to experience the professional development available through the annual conference.

## Practice Hours Audit

It's that time of year again when Manitoba pharmacists are asked to confirm their practice hours as part of the College's Quality Assurance/Continuous Improvement Program. In accordance with Section 14(b)(i) of The Regulation to *The Pharmaceutical Act*, to renew a practicing licence a pharmacist must provide evidence satisfactory to the Registrar that, in the three-year period before the date of application (renewal of a practicing licence), he or she has supervised or engaged in the practice of pharmacy for at least 600 hours.

A random 20% selection of practicing pharmacists will be advised that they have been selected to participate in the Practice Hours Audit. The selected members will be notified via email today and provided with their Licensing Audit Form Letter. Participants in the audit will be required to have their employer(s) confirm their hours worked at their place of employment.

The deadline to submit the completed Licensing Audit Form Letter is **Friday, March 10<sup>th</sup>**, so please check your email to confirm if you
