College Receives Annual Dr. John Wade Patient Safety Initiatives Grant

The College is pleased to report it has been selected to receive one of two Dr. John Wade Patient Safety Initiatives Grants (Grant) for 2018 by the Manitoba Institute for Patient Safety (MIPS). The College will receive a \$6,200 grant to create a *Just/Safe Toolkit* for community pharmacies to help support a cultural shift from a blame-and-shame to a just-and-safe approach to medication incidents and near misses throughout the province.

adaptation of prescriptions to provide oxycodone and acetaminophen separately. The [Practice Direction – Adaptation of a Prescription](#) states that a pharmacist may adapt a prescription when they are knowledgeable of the patient, the condition being treated and if the prescription product is not commercially available or may be temporarily unavailable.

In this case, however, the College does not advise pharmacists to adapt these prescriptions for oxycodone and acetaminophen combinations. Due to the nature of the medication and the increased risk for abuse and diversion of straight oxycodone, the College advises pharmacists to consult with the prescriber to discuss alternatives that are best for the patient, rather than adapting these prescriptions to straight oxycodone and acetaminophen. If the prescriber wishes to have the patient take the medication separately, the current prescription cannot be modified, but rather a new M3P prescription is required for oxycodone.
