### Joint Statement

The College of Pharmacists of Manitoba (College), in collaboration with the College of Physicians and Surgeons and Manitoba's nursing Colleges have released a Joint Practice Statement titled "Rural, Remote and Underserved Populations: Access to Prescribed Medications." The Joint Practice Statement is in effect immediately.

Rural, remote and underserviced populations are at risk for potentially harmful delays in care because of barriers to timely access to services. This Joint Practice Statement outlines expectations for prescribers, nurses, and pharmacists in situations when patients in rural, remote or underserviced communities do not have access to a pharmacist. The Joint Practice Statement applies in these practice settings when there is a client-centered need to provide a short-term supply of medication, the client is at risk of experiencing harmful delays in care, the facility has safe, appropriate storage requirements for the drug, and a pharmacist can review the prescribed medications and enter them into DPIN as soon as possible but no later than 48 hours after the medication has been supplied.

## Final Opportunity Approaches for Pharmacy Assistants to Complete PEBC Pharmacy Technician Evaluating Exam

Manitoba pharmacy assistants have **just one opportunity** left to complete The Pharmacy Examining Board of Canada (PEBC) Evaluating Examination before the **December 31, 2018**, deadline if they are pursuing status as a pharmacy technician through the PEBC Evaluating Examination and National Association of Pharmacy Regulatory Authorities (NAPRA) National Pharmacy Technician Bridging Program.

Further, individuals who wish to become listed pharmacy technicians with the College through the PEBC Evaluating Exam and NAPRA Bridging Program must complete and submit all requirements for listing as a pharmacy technician by **December 31, 2019**. Following this deadline, individuals seeking to become pharmacy technicians in Manitoba will be required to complete a CCAPP accredited pharmacy technician program to become listed as a pharmacy technician under *The Pharmaceutical Act*.

PEBC Qualifying Examinations:

 Saturday, September 8, 2018 (MCQ), and Sunday, September 9, 2018 (OSPE); application deadline is Friday, June, 8, 2018 (Winnipeg site available)

Applications must be RECEIVED by the PEBC office no later than the application deadline. The College encourages pharmacy managers to share this important information with their pharmacy staff who may wish to seek status as a pharmacy technician, without having to complete a CCAPP accredited pharmacy technician program.
